Covid-19: Cogepart, a leader in home food delivery, is mobilising its forces to help the most vulnerable

In response to an unprecedented health crisis, Cogepart introduces *Mon Petit Livreur by Cogepart*, a free home delivery service for vulnerable, housebound people.

Cogepart launches a major solidarity initiative across France by **making its fleet of 2,000 delivery drivers available to local shops and its network of large partner merchants.**

The goal: The purpose of the scheme is to provide elderly, vulnerable or housebound people with a **supply of essential food and healthcare items.**

Cogepart is also offering an initial amount of 10,000 free home deliveries to charitable organisations that support vulnerable people.

Founded in Marseille with branches in 67 French towns and cities, Cogepart is a leading player in the market for temperature-controlled and non-refrigerated last-mile logistics (end-customer delivery). Cogepart works with thousands of French companies.

Details of the scheme: the charity or merchant partner records the delivery job on behalf of the recipient or its customer on the "bycogepart.fr" website (on the "Mon Petit Livreur" page). Delivery is scheduled for within the next few days. **The Mon Petit Livreur Solidaire project is designed to ensure that households receive supplies of essential items and is not an emergency service.**

Strict safety procedures are followed; packages are placed on the customer's doorstep, with no physical contact between them and the delivery driver. The initiative is being launched in a number of French cities (Paris, Lyon, Marseille, Nice, Montpellier, Toulouse, Bordeaux, Strasbourg, Nantes, Clermont-Ferrand, Angers and Rennes).

Jérôme Dor, Founder and Chairman of Cogepart: "*In this crisis, the most vulnerable people or those with Covid are isolated and find it hard to do their weekly shop for basic necessities, medicines, food, and so on. We want to stand together with the medical profession, government and private and personal initiatives to offer a service designed to shatter this isolation. My Petit Livreur by Cogepart is a vital initiative and a natural extension of our DNA.*"
