Intys, Belgian consultancy firm signs a second acquisition in France, backed by its investor Omnes

Intys has acquired, with the support of its investor Omnes, JAGGAER BPO, the outsourcing arm of JAGGAER France. It is the second acquisition completed by the Belgian consultancy firm since Omnes' invested in the company in July 2019.

Based in Brussels, Intys is one of the leading consultancy firms in Belgium. A multi-specialist player, Intys possesses recognised expertise in the healthcare, energy, industrial and financial services sectors. Its 80 clients include leading companies and institutions in Belgium, Luxembourg and France. The firm generated a €39 million turnover in 2020 and has a staff of 400.

JAGGAER, an international spend management company, is refocussing on its software business with its Source-to-Pay suite JAGGAER ONE and has decided to de-merge from its two business lines JAGGAER BPO and JAGGAER Advisory. Intys has bought the JAGGAER BPO (Business Process Outsourcing) division, a specialist player in the procurement sector. It provides operational support to its clients and can oversee the management of specific procurement families under the framework of long-term assignments.

The JAGGAER Advisory division has been purchased by the audit and consulting firm PwC France and Maghreb.

This acquisition fits in perfectly with Intys' strategy defined in 2019, which notably focusses on growth via acquisitions based around geographical and business synergies.

Philippe Metz, the CEO and co-founder of Intys: "For the past few years Intys has focussed on offering its clients contractual and support models that are increasingly innovative, simple and straightforward, which ensures ongoing excellence in terms of the quality of deliverables. I firmly believe that beyond the obvious geographical and sectorial synergies, JAGGAER BPO's know-how and experience in the field represent a major asset for Intys, which will generate more than 20% of its income thanks to this style of contractual relationship".
